## Champions For Housing

#### Lorraine Cochran-Johnson



Lorraine Cochran-Johnson is originally from Greenville, Alabama and an eighteen-year DeKalb County, GA resident. Lorraine attended Troy University where she received a B.S. Degree in Political Science and Criminal Justice; a M.S. in The Administration of Criminal Justice; and, received the M.P.A. in Public Administration with a concentration in Economic Development and Grant Writing from Auburn University before attending John Marshall Law School.

Lorraine has over a decade of experience in print media, mass communications, and management. A seasoned grant writer, Lorraine has developed state and federal proposals since 1994 that resulted in the procurement of millions in CDBG funding for state and local entities through the Auburn University Economic Development Institute. As a community activist and parent, Lorraine is a past president of Pine Ridge Elementary (2006-2007) and Chapel Hill Middle School

(2008-2009) PTA and independently secured over \$200,000 in funding for school revitalization and digital technology in 2017.

As a professional, Lorraine spent over a decade at Creative Loafing Newspaper. An entrepreneur, Lorraine founded Salons Unlimited Magazine, a publication that started with 5,000 print issues in Atlanta and grew to a 56,000 circulation in 31 U.S. cities in three years before being sold in 2010. In 2009, Lorraine became a founding member of United Front Media, a premiere film and visual media company specializing in content development where she produced commercials for the City of Atlanta, MARTA, KIA and Hartsfield-Jackson International Airport. In 2015, Lorraine joined Real Times Media as the General Manager of the Atlanta Daily World Newspaper and Associate Publisher of Who's Who In Black Atlanta and VP of Business Development for RTM Properties - AtlantaDailyWorld.com and Atlanta Tribune: The Magazine, before resigning to pursue public service.

Lorraine strongly supports positive initiatives in economic development, education, public safety and home ownership. Moderator of DeKalb's PDS-24 television show Engagement Now, Lorraine works with show producers to develop content crafted around issues relevant to modern education. The wife of Ret. Lt. Col. William H. Johnson, III, niece of Annie Page and the Mother of Martin Luther King Jr. High School International Baccalaureate student Zion Cochran, Lorraine values family and community above all else.

Mercy Housing Southeast has developed or preserved 45 properties delivering over 3,192 affordable rental homes since 1996 and has also been recognized with many accolades in the housing industry, including The Magnolia Award, Affordable Housing Finance Award, The Charles L. Edson Tax Credit Excellent Award, The National Trust for Historic Preservation Award, and ULI Development Excellence Award.

Mercy Housing Southeast creates stable, vibrant, and healthy communities for low- income families and seniors across the southeast. #### Elizabeth J. Appley, Attorney & Public Policy Advocate



Elizabeth J. Appley is an experienced attorney and public policy advocate engaged in private practice in Atlanta. She has won groundbreaking cases in state and federal court in the areas of health law, education, employment discrimination, constitutional law, police misconduct, reproductive freedom, and disability rights. Elizabeth is certified as a Mediator and Arbitrator.

Elizabeth represents numerous organizations at the state capitol and has secured significant legislative successes at the Georgia General Assembly on budget and policy issues over the past twenty-nine sessions. In addition to other clients, in 2022 she represents Georgia Advancing Communities Together (Georgia ACT), the Georgia Supportive Housing Association, Enterprise Community Partners, Presbyterians for a Better Georgia, and 9to5 Georgia working to enact policies and secure resources to prevent and ameliorate homelessness and increase state support for safe, decent, stable, and affordable housing.

Among her most recent successes, Elizabeth created the Healthy Housing Georgia coalition, passed a ban on retaliatory evictions, strengthened unemployment insurance protections for workers, helped amend the state Fair Housing Act, successfully fought efforts to criminalize homelessness and divert funding away from permanent supportive housing and into state sanctioned tent camps, passed legislation to prevent childhood lead poisoning, and increased funding to the state housing voucher program. She continues to lead efforts to pass eviction protections and increase access to emergency rental assistance for vulnerable Georgians.

Elizabeth is a Past President of the Georgia Association for Women Lawyers (GAWL). She was a founding board member of the Georgia Budget and Policy Institute (GBPI) and has served on the boards of the Mental Health Association, ACLU, Anti-Defamation League, Black Women's Health Center, and many others.

A graduate of Hampshire College in Amherst, Massachusetts, she received her law degree from Columbia University School of Law in New York City. She lives in Atlanta with her husband, N. Sandy Epstein, Esq. They are proud to have two grown sons and a wonderful daughter in law, Benjamin, Joseph, and Danielle.



#### Jason Becker, U.S. Department of Housing & Urban Development



Jason L. Becker currently serves as a Senior CPD Representative with the US Department of Housing and Urban Development. Before arriving at HUD, he was the Compliance Manager for Government Grants at the City of Atlanta. Jason spent ten years with Habitat for Humanity International, where he worked on the Self-Help Homeownership Opportunity Program and then led a team of six compliance Officers administering Habitat's \$135M Neighborhood Stabilization Program award from HUD, where Habitat provided over 1300 new and rehabbed homes to low-income homebuyers. He previously worked for Brevard County, Florida, Fannie Mae, as well as in the Office of US Senator Bill Nelson of Florida. Jason has a MS in Political Science from Florida State University and is a Doctoral Candidate in Public Administration at Valdosta State University.



#### Daniel Blackman, Environmentalist, Civil Rights Activist, & Public Servant



Daniel Blackman is an American environmentalist, civil rights activist, and public servant. He is the former Director of Advocacy and Strategic Partnerships for The Martin Luther King, Jr. Center for Nonviolent Social Change ("The King Center"), author of the book Nationalism with Compassion, writer-producer at Conscious Animal, former Regional Administrator, and currently serves as Senior Advisor for STEM Recruitment and Diversity at the US Environmental Protection Agency. The son of immigrants from Barbados, Daniel is dedicated to economic opportunities for marginalized Southern communities, environmental justice, social equity, and narrowing the wealth gap.

Blackman's passion for public service and activism was shaped by his upbringing in a family with a strong tradition of service and diplomacy. His mother, an Army wife, instilled in him the values of sacrifice and community, while his father, a United States Army Ranger, exemplified honor and

dedication. He draws inspiration from his grandfather, who served as a diplomat to the United Nations. Blackman's journey in activism and community empowerment began during his college years, where he gained diverse experiences through internships at Walt Disney World, Arista Records, and Universal Music Group. However, it was his encounters with Civil Rights leaders like Congressman John Lewis and Reverend C.T. Vivian who ignited his commitment to the modern civil rights movement. Motivated by their courage and determination, he sought to find his place in reshaping democracy and fighting for justice.

Throughout his career, Blackman has made significant contributions to sustainable development, environmental protection, and social equality. His work includes advocating for equitable economic opportunities, addressing education disparities, combating food and broadband deserts, championing public health and transportation accessibility, and supporting innovative clean energy solutions. Blackman holds a deep sense of pride in his alma mater, Clark Atlanta University, where he gained valuable knowledge and skills that have propelled him to his current leadership position. His work continues to make a lasting impact, inspiring individuals and communities to strive for a more sustainable and equitable future.



#### Wesley Brooks, Department of Community Affairs



Having previously served at DCA as the Manager of Housing Policy and Outreach, Wesley Brooks has direct experience with several state and federal housing programs, including the HOME Program, down payment assistance, and mortgage revenue bonds.

Most recently, he was the Senior Vice President and Homeownership Lead for the Wells Fargo Foundation, where he led philanthropic efforts to address housing affordability across the United States, with a particular focus on homeownership. He worked closely with Habitat for Humanity to further develop their relationship, which has produced nearly 1500 homes for families over the last 10 years. He worked on increasing the diversity of housing professionals with the National Urban League by training new appraisers of color. He

managed down payment assistance programs that reached diverse markets.

Brooks served as the Chief Housing Officer for Atlanta Habitat for Humanity, one of the largest non-profit builders of affordable, single-family homes in the southeast.
